# PWIA Coronavirus (COVID-19) Guest Liability Waiver and Pool Rules

**BACKGROUND FOR POOL OPENING:** As of March 23, 2021, the Santa Clara County has been moved to Orange tier under California's Blueprint for a Safer Economy. This allows for the pool to open at limited capacity. The status may change before or during the swim season. Based on changes a new waiver may be required.

WHAT THIS MEANS FOR PWIA: The PWIA Board is committed to the pool operating in accordance with the revised order and is making a good faith effort to comply as outlined below.

**COVID-19 LIABILITY WAIVER:** Please be advised that the use of the pool presents guests with a risk of contracting the COVID-19 virus, even when PWIA staff, members, and guests take reasonable steps to comply with the conditions set forth below. By signing this liability waiver, the signing guest, and every household member who resides at the address set forth below, hereby waive the right to bring any and all liability claims, civil actions and/or damages claims against PWIA, the PWIA Board, and/or PWIA employees arising out of the contraction of the COVID-19 virus. No minors under the age of 18 may sign this waiver.

Guests using the pool must agree to these pool operating conditions by initialing and signing this agreement and abiding by its conditions. Failure to follow these conditions will result in disciplinary action, up to and including termination of swimming privileges.

### County-Required Operating Rules for Outdoor Swimming Pools and PWIA's Policies to Comply

**Description and Conditions to Operate.** Outdoor swimming pools may operate subject to the limitations listed below plus those required elsewhere in the Santa Clara County Order (https://www.sccgov.org/sites/covid19/Pages/public-health-orders.aspx).

Individuals who have any COVID-19 Symptoms will not be allowed access to the facility.

Social Distancing Protocol displayed at the pool must be adhered to at all times.

**Social Distancing in the Water:** Swimmers and family groups shall always remain at least six feet apart from other swimmers or family groups.

Face Masks Are Required in order to enter the PWIA facility and shall be worn at all times except when swimming or eating. They should not be worn while in the water.

**Facilities:** Restrooms, Picnic Tables, BBQ and Changing rooms will be open and available for use and Social Distancing Protocols must be adhered to. The pool house, Showers, Lounge chairs, and drinking fountain will remain closed. Sanitizing supplies will be available in the restrooms for guests You may bring your own chairs and wagons.
