Community Concerns:

- Polar Plunge
 - Given the positive attendee feedback and value the board feels this event contributes to the community, we plan to continue to host a Polar Plunge with the appropriate safety measures in place.
- \$20 late fee for late registration
 - In order to process the pool's swim membership in a timely manner, including managing the waitlist and preparing for opening day for hundreds of families, a nominal late fee of \$20 to remind people to sign-up before the deadline was added this year.
- Dog poop on Hill Park
 - The board made a choice to broadcast the community concern, as it affects the street in front of our pool, which kids and members walk along. We want to get

ahead of it before the season begins. Please be responsible when walking your pets.

 - a. As a follow-up to a member's concern voiced during the 2025 annual membership meeting, Matt inquired with the pool's insurance broker regarding increasing the pool's business insurance. A summary of current coverage as well as incremental costs to increase the pool's coverage is below.
 - Current annual amount: \$6,173 includes \$2M of business insurance and \$2M of directors and officers insurance.
 - Increasing both limits to \$3M would be approximately \$729 more per year bringing the total to about \$6,902.
 - Increasing both limits to \$4M would be approximately \$1,438 more per year bringing the total about \$7,611.
 - Matt motioned the increase in insurance coverage to \$3,000,000. Discussion was had. Bonnie seconded. Motion approved by the board.
